

PRIVILEGES FOR PARTICIPATING IN THE 2025 JOINT CORPORATE RESEARCH MEETING 1

A set of "refreshments" & "meal voucher to be used at Cafeteria No. 1" will be given as a set!

Use of meal vouchers

Available period: 10/16(Thu) - 10/31(Fri) *Except Saturdays and Sundays Meal vouchers may be used in Cafeteria No.1 on weekdays from 11:00 a.m. to 1:30 p.m. Meal vouchers may be used when the total amount at the time of settlement is equal to or greater than the total number of meal vouchers used, or when the total amount at the time of settlement is equal to the total number of meal vouchers used. Meal vouchers can be used as follows.

1) Submit meal ticket (with student ID number and name filled in) at the cashier.

2Up to 4 meal vouchers can be used at once at checkout

Conditions for receiving participation benefit ①

Conditions for receiving the gift:

1) Attend joint company information sessions and visit at least one company booth per day!

② Get a stamp on the "Participation Benefit ① (Food Support) Secretariat Confirmation Section" of the pamphlet!As proof of visiting at least one participating company booth per day, the secretariat will stamp the pamphlet on the following dates.

Period: October 14 (Tue) to October 17 (Fri) *Proof stamps for same-day visits must be stamped by the secretariat on the same day.

Reception location: Commissary 1F
Reception Hours: 1:00 PM to 6:40 PM

How to receive stamps: Stamps will be given after confirming that the stamp rally page in the designated pamphlet has been stamped and the necessary information has been filled in.

Important note: For example, to prove that you visited a company booth on the 14th, you must have the stamp given by the secretariat at the designated location during the reception hours on the 14th. Please note that stamps cannot be given on other days.

How to receive participation benefit 1

Exchange period: October 16 (Thu) to October 22 (Wed) *While supplies last.

*If you wish to receive food assistance for October 14 (Tue) and October 15 (Wed), the earliest date is October 16 (Thu).

Exchange Location: Commissary 1F Exchange Time: 11:00 AM-12:15 PM

Exchange Method: Exchange is available upon confirmation of the stamp on the "Participation Benefit (Food Support) Office Confirmation Section" of the pamphlet and verification of your student ID.

Precautions

①If you lose your participation benefits, they will not be reissued.

②Food support is limited in quantity, so even during the exchange period, it will end when the stock runs out.

③If any irregularities are found regarding food support, the secretariat will contact you and ask you to pay the equivalent amount of the benefits in cash, so please be aware of this.

Support for food expenses
