Call for Applications for a Tenure-Track Position at Assistant Professor Level
(The Hatamoto Research Unit)

Nagaoka University of Technology invites applications for a tenure-track faculty position as a "Specially Appointed Assistant Professor (or Specially Appointed Lecturer) for Academia-Industry Fusion." This role actively promotes interdisciplinary research and industry-academia integration, with an appointment term through March 31, 2032.

As a university selected for the "Program for Forming Japan's Peak Research Universities (J-PEAKS)" sponsored by MEXT and JSPS, Nagaoka University of Technology is strongly driving societal transformation through "convergent knowledge" that transcends academic disciplines and organizational boundaries. To achieve this key priority, we have launched a unique organizational reform—establishing new "Research Units"—and are seeking a researcher to jointly advance cutting-edge interdisciplinary research and its societal implementation.

The appointee will be affiliated with the Top Runner Incubation Center for Academia-Industry Fusion and will be able to focus primarily on research. To support this, startup funds will be allocated and administrative duties will be minimized.

Tenure will be granted based on an interim evaluation and a final evaluation. Candidates who demonstrate particularly outstanding achievements in the interim evaluation may receive tenure at that stage.

1. Position Available

Specially Appointed Assistant Professor for Academia-Industry Fusion (or Specially Appointed Lecturer for Academia-Industry Fusion)

*In principle, the successful candidate will be appointed as a Specially Appointed Assistant Professor for Academia-Industry Fusion. However, depending on the results of the selection review, the appointment may be made as a Specially Appointed Lecturer for Academia-Industry Fusion if deemed particularly necessary.

2. Research Fields

Applicants are invited internationally for one position in the following research area.

【Details of research area】

Environmental engineering research on microbial resource recovery and recycling, with a particular focus on environmental microbiology and bioelectrochemistry. We seek candidates who can advance research in areas such as anaerobic biological treatment and anaerobic digestion (methane fermentation). Potential research topics include the control of microbial functions and metabolism through interspecies electron transfer and

interactions with electricity, light, viruses (phages), and other factors, as well as the production of valuable materials and energy by harnessing these mechanisms. We welcome candidates who are enthusiastic about interdisciplinary research spanning fundamental mechanistic studies, bioreactor development and demonstration, and real-world implementation.

【Desirable candidate profile】

Individuals with a strong passion for research in the specialized field listed above, with a commitment to deepening and advancing the discipline.

3. Job Description

(Immediately after hiring)

As a tenure-track faculty member, you will conduct research in the above-mentioned specialized fields within a research unit*.

*A research unit is a group of faculty members from different disciplines formed to promote interdisciplinary research.

(Scope of change) Operations as determined by the university.

4. Qualifications

Applicants must hold a doctoral degree obtained within the past 5 years or be expected to obtain one by the time of appointment, and be actively conducting research in a field relevant to the research areas listed above.

5. Selection Process

Document screening will be conducted based on the research achievements presented in the application materials, evaluated from the following perspectives: (1) establishment of innovative research fields aiming for academia-industry fusion, (2) creation of new industrial technologies, and (3) academic originality and exploratory potential (research seeds). Applicants who pass the document screening will be invited for an interview and a presentation.

Applicants are responsible for their own travel and accommodation expenses for the interview and the presentation.

6. Salary

Salary is paid under a new annual salary system and will be determined by taking into account professional experience, research achievements, and other relevant factors in accordance with university regulations.

7. Research Environment Setup Funds (Startup Funding)*

As startup research funding, 2 million yen will be allocated in the first year (3 million yen if appointed as a Specially Appointed Lecturer), followed by 1 million yen per year from the second year onward (*Limited to individuals under 40 years of age at the time of appointment).

8. Research Environment

Tenure-track faculty members are guaranteed a research environment under the leadership of a Research Unit Leader, enabling them to dedicate themselves to their research activities.

11. Tenure Evaluation and Promotion

Tenure-track faculty members will undergo an interim evaluation in their 3rd year after appointment; candidates with particularly outstanding achievements may be granted tenure at that stage. A final tenure review will be conducted in the 5th year, and candidates who pass the review will be granted tenure. Please note that the tenure review will be evaluated against the designated tenure-track evaluation criteria.
